#### 2.0 GUIDELINES

##### 2.1. NOMINATIONS

- 2.1.1. Registered Financial members of the Society who desire to contest election must meet all criteria for election.
- 2.1.2. The nominee must have participated in NSN AGM within the last 3 years
- 2.1.3. The nominee shall be financially up-to date.

##### 2.2. LETTER OF INTENT

- 2.2.1. All those interested in election into any position should put themselves up through a letter of intent to the Chairperson of the nominating committee at the following address: [nsnnomination24@gmail.com](mailto:nsnnomination24@gmail.com)
- 2.2.2. A copy of such letter should be sent to the National General Secretary of the Society [info@nutritionnigeria.org](mailto:info@nutritionnigeria.org)
- 2.2.3. For the post of President and Vice President, candidates must send in a two page single spaced treatise of the plans and programmes they wish to implement if elected. All other candidates must write one page of their vision for the Nutrition Society of Nigeria.
- 2.2.4. Current members of Council shall be listed to contest their current positions or other position, if they indicate their interest and are qualified to do so.
- 2.2.5. The letter of intent for each candidate must be accompanied by an abridged curriculum vitae, which will be published and circulated to the members electronically
- 2.2.6. All nominations and letters of intent with the accompanying document stated above must reach the Chairman, NSN 2024 Nominating Committee immediately.

#### 3.0 ELECTIONS

- 3.1. Elections shall be conducted at the next Annual General Meeting of the Society by members physically present. No postal ballot shall be allowed at the election.
- 3.2. Voting shall be by secret ballot
- 3.3. Only financial members may vote or be voted for
